AGREEMENT BETWEEN

CITY OF OVERLAND PARK, KANSAS AND THE ARTS AND RECREATION FOUNDATION OF OVERLAND PARK, INC., AND THE FRIENDS OF THE ARBORETUM

FOR FUNDING THE CONSTRUCTION OF A WELCOMING GARDEN AT THE ARBORETUM AND BOTANICAL GARDENS

THIS AGREEMENT is made and entered into this _____ day of _____, 20__, by and between the City of Overland Park, Kansas, hereinafter the "City", and the Friends of the Arboretum and the Arts and Recreation Foundation of Overland Park, Inc. hereinafter the "Friends";

WITNESSETH:

WHEREAS, the City and the Friends have agreed to cooperate with respect to the construction of a welcoming garden to be located at the Overland Park Arboretum and Botanical Gardens:

NOW, THEREFORE, in consideration of the mutual agreements herein contained, the parties hereto have agreed, and hereby agree, the City for itself and its successors, and the Friends for itself, and its successors, as follows:

ARTICLE I. RESPONSIBILITIES OF FRIENDS

- A. Friends shall be responsible for funding the purchase of materials, construction services, and landscaping for the welcoming garden in an approximate amount of \$143,770.
- B. Friends shall appoint one representative to assist the City Project Coordinator in obtaining bids, plans, permits, etc., and to serve as advisor on any design or construction decisions.
- C. Friends agree that once the welcoming garden is constructed, it will become the property of the City and the ongoing maintenance of the welcoming garden will be the responsibility of the City.

ARTICLE II. RESPONSIBILITIES OF THE CITY

- A. The City will provide a project coordinator who will be responsible for obtaining building permits, coordinating the ordering of materials, supplies, and equipment, and providing supervision of the construction of the welcoming garden.
- B. The City will provide personnel and equipment needed to construct the welcoming garden.
- C. The City shall be responsible for funding the purchase of materials, construction services, and equipment for the welcoming garden in an approximate amount of \$41,500.

ARTICLE III. GENERAL PROVISIONS

A. This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements, whether oral or written, covering the same subject matter. It is understood and agreed between the parties that there shall be no waiver or modification of the Agreement unless such waiver or modification is first reduced to writing and signed by all parties hereto.

- B. All notifications to the Friends shall be sent to Vicki Lilly, 4209 W. 104th Terrace, Overland Park, KS 66207, unless different notification information shall be given to the City in writing. All notifications to the City shall be sent to the Director of Parks and Recreation, City Hall, 8500 Santa Fe Drive, Overland Park, KS 66212, unless different information is given to the Friends in writing.
- C. Either party may terminate this agreement if it becomes apparent during the planning process that there will be additional costs above what is outlined in this agreement. Either party may terminate this agreement during the planning process if any issues arise that are not acceptable or would make the project undesirable. Either party may terminate this agreement if final bids for the welcoming garden and all the materials and services required to construct the welcoming garden exceed the financial commitment of either party as outlined in this agreement.

IN WITNESS WHEREOF, the City of Overland Park, Kansas, has caused this Agreement to be executed on its behalf, thereunto duly authorized, and the Friends have executed this Agreement in the prescribed form and manner, the day and year first above written.
