IN THE MUNICIPAL COURT OF OVERLAND PARK, KANSAS ADMINISTRATIVE ORDER 2017-3 EFFECTIVE DATE May 17, 2021

Pursuant to O.P.M.C. 2.33.310 and O.P.M.C. 2.33.320 and K.S.A 12-4215, all persons charged through Overland Park Municipal Court with a city ordinance violation must be allowed an opportunity to sign a notice to appear (NTA); or in the case of an electronic citation verbally acknowledge and promise to appear on or before the date set at or with the Court on any city charges and be released from further detention unless:

- 1) the person refuses to give a written promise to appear in court when served with a notice to appear or personal recognizance (PR) bond;
- 2) The person is unable to provide identification of self by presenting a valid driver's license or other identification giving equivalent information to the law enforcement officer. See ** below.
- 3) The person is not a resident of the state of Kansas; or
- 4) The law enforcement officer has probable cause to believe that the person may cause injury to self or others, to include law enforcement officers, or may damage property unless immediately arrested.

In the case of a traffic infraction or tobacco infraction the person charged must be released after service of a NTA, no exceptions.

In addition, this Court has designated additional ordinance violations as subject to the signing of a NTA, such that all non-Kansas residents so charged are to be released upon the service of a NTA unless the person is unable to provide identification of self by presenting a valid driver's license or other identification giving equivalent information to the law enforcement officer. Said violations are noted by an asterisk (*). The bond listed for said offenses is only applicable if the accused is not a Kansas resident and identification is lacking as outlined above. All non-Kansas residents arrested for offenses that are not marked with (*) in the following bond schedule, are required to post the bond listed prior to their release.

Pursuant to K.S.A. 12-4302 and by this administrative order all Overland Park Police Officers are authorized to complete, sign and serve an appearance bond without surety otherwise known as a "PR Bond" in the amount indicated on the bond schedule. Every violation in the Overland Park Bond Schedule has a "PR" next to the amount listed, which allows every person arrested the opportunity to post a "PR" bond.

The following bond schedule is adopted effective May 17, 2021. This schedule is applicable only to new arrests. Arrests based on bench warrants are governed by the bond amount and method listed on the warrant.

** acceptable forms of ID include but are not limited to non-expired consular photo ID card, passport, military ID, green card and Native American tribal photo ID.
