ANSWERS TO VENDOR QUESTIONS JULY 16, 2021

1. **Will the City of Overland Park, provide the last 3- 5 years of the following service data? *No further information is available at this time.***

- a. Who is the City's Broker, Carrier, TPA **The City's TPA is Thomas McGee.**
- b. Does the City have a designated Nurse Case Manager through your carrier/TPA? **The City's TPA assigns the Nurse Case Manager when appropriate.**

2. **Employer Services – Will the City of Overland Park provide the following volume for the last 3 years for all the below: *No further information is available at this time.***

a. Drug Screens:

- i. Does the City of Overland Park have a contracted Drug Screen Test Kits, Supplies, Lab, and MRO or will the contracted medical vendor need to provide the Lab and MRO? **MRO services are expected to be provided by contractor; furthermore, drug screening supplies and lab services are expected to be provided by the contractor.**
- ii. Does the City of Overland Park have a Consortium for Random pulls or does the medical vendor need to provide this in the bid? **Please clarify what you are asking.**
- iii. What would saliva testing be used for? **Drug testing.**

b. Audiogram Testing

1. Will the City of Overland Park like a line item bid for the audio booth costs? **No.**
2. Will space for the Audio booth be available if brought onsite for clinical use? **This will not be allowable. All services are provided at the vendor site.**

Christmas, New Years, fourth of July, Labor Day, Memorial Day, MLK Day, Thanksgiving and the Day after.

- v. How many after-hours calls were serviced in the last 3 yrs. and what services? **No additional information is available at this time.**
- 3. Ancillary Services not listed on the RFP Bid:
 - a. Would the City of Overland Park like a Telehealth/Telemed option and pricing added in the proposal for after-hours triage and care? **Not necessarily.**
- 1. Section C Pricing Proposal Page, I. – V.: For the individual service costs listed in each of these sections, is it acceptable for bidders to list “Included” if the service is covered under their proposed total annual fee and only provide the individual service cost if it is a pass through fee to the City? **Yes**
- 2. Section C Pricing Proposal Page: Is a candidate disqualified if they do not cover after hours Occupational Health services? **Contractor must provide alternative options for 24/7 coverage.**
- 3. Section C Pricing Proposal Page: If weekend and holiday Occupational Health Services coverage is required, please clearly define the number of hours and days on the weekend as well as the holiday hours that bidders are expected to cover Occupational Health Services. **24/7**
- 4. II. Background Information, page 3: Please provide a chart of high-volume services utilization data for 2020 as well. **No additional information is available at this time.**
- 5. Vi. Evaluation and Selection Process: Is a Respondent disqualified if they do not have Board Certified Occupational Medicine physician on staff? **Not unless one is needed for certain functions, i.e., treadmill stress test.**
- 6. VII. Award of Agreement: Is the City open to a multi-year contract arrangement? **Yes**
